



PAYMENT POLICY

Northwestern Obstetrics and Gynecology Consultants is dedicated to your health and wellness. Some services our physicians recommend may not be covered by insurance, including ultrasounds, IUDs, genetic testing, labs, and certain procedures. If your plan does not cover these, you are responsible for the balance. If concerns are addressed during your preventative, an additional visit may be billed.

Preventative Visits include- History update, physical exam, medication review/refills, counseling, and screening tests.

Deposits

- All obstetric patients are required to pay a \$500 OB deposit at the time of scheduling. This deposit will be applied toward any balance incurred during your pregnancy.
- A \$250 deposit is required for all in-office procedures involving anesthesia.
- A \$500 deposit is required for all hospital surgeries

All deposits must be paid prior to scheduling your procedure.

Copays- Copay payments are expected at the time that services are rendered.

Self Pay Patients - Are required to pay in full for services and/or labs at the time of service.

Insurance Claim- NOGC will submit an insurance claim for your current services. Insurance companies are required to pay their portion of the claim within 45 days of receipt. When your insurance company pays NOGC for a service, you are only responsible for what is considered the patient portion of the claim.

- Telemedicine Appointments will be billed and submitted to your insurance.
- Medical Advice (provided through the Portal or by Phone) may be submitted to your insurance.

Patient Portion- After your insurance company pays their portion of the claim, you are responsible for the patient portion. Your credit card will be automatically charged for the amount due if payment is not received within 15 days after the first billing statement notification is sent. A receipt will be uploaded to your portal after payment is processed. If your credit card is declined, there will be an additional \$50 fee.

Cancellation Policy-

- New Patient, Established, gynecology, and ultrasound appointments require a notice of two (2) business days for all cancellations. If an appointment is canceled or rescheduled in less than two (2) business days, you will be charged \$100 for office visits
- In-office procedures requiring anesthesia, a minimum of one (1) week notice is required for cancellation or reschedule . A \$250 cancellation/rescheduled/No Show fee will apply for cancellations made within this timeframe.
- Hospital-based surgeries, a minimum of two (2) weeks notice is required for cancellation or rescheduled . A \$500 cancellation fee will apply for cancellations made within this timeframe..

WE STRONGLY SUGGEST THAT YOU MONITOR YOUR ACCOUNT AND THE EOB FORMS THAT YOU RECEIVE FROM YOUR INSURANCE COMPANY. YOU WILL NEED TO RESOLVE ANY DISPUTES WITH THEM INVOLVING PATIENT PORTIONS
